What is included in the price

7 nights accommodation and all meals and services as set out in our brochure and web site.

What is not included

Travel, transfers to and from the airport, holiday and medical insurance, lift passes, ski hire, ski tuition, ski equipment, lunches, evening meal on the staff day off, breakfast on arrival and nanny services.

Reductions

5% Returning client discount.

Booking/Payment

Payment by cheque or bank transfer, should be made to Ski Moments Ltd. A deposit of £150 per person is payable at the time of booking. The booking form must be completed and signed by the party leader and returned to Ski Moments with the deposit. No contract will exist until Ski Moments has received the completed booking form and has confirmed your booking by sending you an invoice.

For bookings made within 8 weeks of departure, full payment must accompany the booking form.

The balance of the holiday cost must be paid at least 8 weeks prior to departure. Should you fail to make payment in full and on time Ski Moments reserves the right to cancel your booking and your deposit will be forfeited.

Cancellation

If Ski Moments cancels – We reserve the right to cancel your holiday as a result of unusual and unforeseeable circumstances beyond our control.

If for any reason beyond our control it becomes necessary to cancel a holiday on or before the date when final payment is due, we shall offer a refund of all monies paid.

If you cancel – All cancellations must be made in writing to Ski Moments by the person who signed the booking form and proof of posting kept.
